Pavilion Rental Rules & Regulations

- Pavilion rental fee is for the period of 9:00 a.m. to 6:00 p.m.
- Pavilion is intended for private parties such as birthdays, picnics & family events.
- Reservation requests can be made in person or by phone at the Ranger Station.
- Reservations are not confirmed until full payment received & receipt is obtained.
- Damage / cleaning deposit (\$50.00) is due upon arrival the day of rental & will be refunded once confirmation from staff. The Park reserves the right to claim the entire deposit for any breach of this agreement.
- Entrance fees are not included in the rental fee. Entrance fees are \$4 per vehicle, for single occupant, and \$5 per vehicle, for two to eight persons.
- The contact person listed is responsible for the group adhering to Park policies.
- All vehicles must be parked in the designated parking areas only.
- Alcoholic beverages & fireworks are not permitted in Florida State Parks.
- Tiki torches & open flames are not allowed.
- Confetti, glitter, balloons, pinatas are prohibited as they are hazardous to wildlife.
- Banners, signs & decorations can only be attached with tape or string. Staples, pushpins, nails, glue, etc. are not permitted for use. All decorations must be removed prior to leaving the Park.
- All trash must be picked up & placed in appropriate receptacles. Bagged trash should be placed in the dumpsters provided.
- Music is to be kept at a low volume as to not disrupt other park visitors.
- No commercial use of facilities, sales or vendors, of any type, may take place.
- Inflatable bounce houses, kid rides, sprinklers, slip-n-slides & pools are **NOT** permitted.
- **Refund and cancellation requests** must be made 15 days prior to the date of the reservation to receive a refund. The original receipt & proof of I.D. are required to obtain the refund.
